Agreement

1. These terms are between the Customer (“**you**”) and The Veggieman Limited (“**us**” or “**we**”) and will govern our provision of goods to you from time to time (“**Goods**”) and related services. In signing the supplier application form or placing an order for Goods from us, you agree that these terms are legally enforceable.

Payment

2. You agree to deduction from your designated bank account by direct debit for payment of the Goods the Thursday of the following week (ending Sunday) after delivery is made.

Warranty

3. We will deliver the Goods to you as arranged in a merchantable state. No further warranty is provided in respect of the Goods or our delivery to you. You are responsible for the proper storage of the Goods so that they do not perish prior to you paying our invoice or using them. We do not guarantee delivery times and are not liable to you for any loss due to late delivery.

Cancelling Orders

4. You may cancel an order until it is delivered to you. Once the Goods have been delivered to you, you must accept them if they are in a merchantable state.

Amendment, Assignment and Termination

5. Either party may end this agreement by notice in writing to the other party. In the event that this agreement is ended, then we will issue you with an invoice and you must pay all amounts that owing. The terms of this agreement will continue until all amounts have been paid by you.
6. We may assign this agreement at any time in our discretion. Should you sell your business or shares in your company are transferred you must inform us and resubmit an application with us. Any guarantee that has been provided to us for your obligations will continue until we release this in writing.
7. These terms may be amended by us by sending you new terms from time to time. If you order Goods from us after being sent new terms this will constitute be acceptance of our new terms.

Personal Guarantee

8. If a person has provided a personal guarantee then they personally guarantee the performance of all obligations of the Customer under this agreement. In the event that we are unable to recover our Goods, the Goods perish after being recovered or can otherwise not be on-sold or we are unable to have all amounts paid to us under this agreement then that guarantor indemnifies us and is liable to us for all loss that results from that including but not limited to all amounts owed to us, our actual costs of collection (extending to third party debt collectors costs and our solicitor and own client costs) and any replacement costs for Goods that are unrecoverable or perished.

Privacy

9. You acknowledge that we may hold your information and you authorise us to disclose this information to third parties. You may contact us at any time to correct any information that we hold for you. This information may be passed to any assignee of this contract due to an assignment by us.

Veggieman Rewards Scheme

10. We may provide rewards in the form of travel vouchers from a supplier nominated by us equivalent to 1% of the value of fruit and vegetables ordered from us and paid for. Such travel vouchers are only redeemable in multiples of \$1,000. Any breach of the terms of trade may at our discretion terminate any accrued rights in relation to the rewards scheme. Any eligibility to travel vouchers is transferrable only at our election. We may at our discretion end the rewards scheme at any time.
